Motorcycle Ride Waiver, Release & Consent

The undersigned will be participating in the “Event” at his/her (my child’s) own risk of, and with full responsibility for, bodily injury, death and property loss or damage.

The undersigned, on behalf of himself or herself,(my child’s) and the undersigned’s heirs, beneficiaries and any other person or entity who is, or may be, entitled to make any claim through, or on behalf of, the undersigned, hereby forever releases and discharges, and agrees to indemnify and defend, Barbs Harley Davidson, Burlington County Military Affairs and the Marine Corps Law Enforcement Foundation, Mcguire Air Force Base, Ft. Dix and any event sponsors, and their respective parent companies, subsidiaries and affiliates, and their officers, directors, shareholders, employees, agents, and representatives (collectively the “Releases”), from, and against, any and all liabilities, obligations, losses, costs, expenses (including reasonable attorneys’ fees), damages, claims, administration of claims, actions, causes of action, suits, liens, and demands of any kind whatsoever, whether known or unknown, accrued or not yet accrued, and whether anticipated or unanticipated, resulting from, caused by, or in any way connected with, the Event, and whether or not resulting to any extent from the negligence or carelessness on the part of any on the Releases.
